## BASIC CONDITIONS:

### 1. LATINCONNECT

Your company must be registered with Latinconnect. Why? That's where you can find all our detailed content such as descriptions, fotos, videos and much more.

### 2. MINIMUM NUMBER OF PARTNERS

In order to participate in the bonus program, you must realise a minimum sales volume of USD 7,500 per partner with at least 4 of the DMC partners listed above.

### 3. CUMULATED MINIMUM SALES VOLUME

The cumulated minimum sales volume with all Latinconnect partner DMCs cannot fall below USD 100,000.



## BONUSPROGRAM:

**If you meet the basic conditions, the following kickbacks on your sales volume await you:**

### 1. LOYALTY BONUS

When you reach 80–100% of your cumulated sales volume of the previous year, we will reward you with a kickback on your cumulated sales volume according to the number of partners with whom you have realized a minimum sales volume of USD 7,500:

Number of DMC partners	Kickback
1–3 partners	conditions for bonus not met
4 partners	0.4%
5 partners	0.5%
and so on with each additional partner	

### 2. REWARD FOR GROWTH

If you meet the conditions for our loyalty bonus, you also qualify for our super premium model, which rewards your growth. In this way your sales volume is given the most leverage. The following formula applies: We compare your generated sales volume **for each DMC partner** with your sales volume from the previous year and pay a super premium of up to 3% for growth **per DMC partner (and not cumulated)** according to the following table:
