However, rapid tests will be conducted on randomly selected travelers upon arrival. Passengers under five years of age and crew members are exempt from this requirement.</p>	<p>To save time in the arrival procedure, we recommend filling out the entry form 72 hours before travel, printing out the QR code or taking a screenshot of it and keeping it ready until arrival, where it will be scanned by the authorities when the passenger is going through customs. Passengers must fill out one form for arrival and one form for departure and the system will generate two QR codes. The QR code will not be scanned upon departure, but it is confirmation that the form has been filled out correctly. If you want to make a change to the form, you will have to fill it out again. Until April 30, 2021, the Dominican authorities exceptionally accept both types of registrations for entry into the country: the previous one via physical forms and the new one via the digital system. From May 1, 2021, the use of digital forms will be mandatory and no other method of providing the information required to enter the Dominican Republic will be allowed or recognized as valid. The Dominican airports have free internet access so that passengers who have not completed the form before the flight can do so when they arrive in the country.
